# Comment

# Is 'value engineering' really valuable?

'Value engineering' is a phrase many readers will recognise. Wikipedia defines it as "a systematic method to improve the 'value' of goods or products and services by using an examination of function", but several participants in a recent joint IHEEM and Building and Engineering Services Association (B&ES) roundtable event in London were sceptical, arguing that, too often, 'value engineering' can see features originally designed into new or refurbished healthcare facilities to enhance their operation and efficiency, reduce their running costs, and enable them to provide better services, 'driven out' on cost grounds, with insufficient thought about the impact on the overall 'quality' of the finished building.

The roundtable saw senior personnel from NHS Trusts, building services engineering companies, architectural practices, construction companies, and the energy sector, debate 'why so many healthcare buildings disappoint their owners and occupants'. Much of the debate centered on the problems caused by 'inadequate management of the commissioning process'. Among the conclusions (see the first part of a two-part report, pages 33-37) was that building and engineering services contractors are often involved too late in the design/construction process to make a difference. Participants also agreed that the skills and expertise required to be an effective NHS client-side project manager are underestimated, and that a lack of contractor/sub-contractor involvement posthandover may see a new healthcare facility not efficiently or cost-effectively operated and maintained longer term.

The roundtable participants sought not only to determine why poor commissioning had become such an issue, but also to identify some potential solutions. IHEEM's CEO, Julian Amey said: "Far from being just a talking shop, events like this provide an excellent opportunity to come up with concrete proposals and ideas that can have a major impact in enhancing the standard of modern healthcare buildings."

# **IHEEM** to help manage clinical technologists' Register

IHEEM has announced that it is to jointly manage, and support, the Institute of Physics and Engineering in Medicine's (IPEM) Voluntary Register of Clinical Technologists (VRCT), in conjunction with IPEM and the Association of Renal Technologies (ART).

This marks a continuation of the close working relationship between IHEEM and IPEM following their signing of a Memorandum of Understanding (MoU) signalling future collaboration late last year.

The VRCT was first opened in August 2000 as a platform for the clinical technologist profession's campaign for statutory regulation with the then Health Professions' Council, and today operates as a means of statutory regulation for such technologists. IHEEM CEO, Julian Amey, elaborates: "With our signing of a new, second Memorandum of Understanding (MoU) with IPEM, the Institute will help process applications for registration with the VRCT, and lend its weight to promoting the benefits of registration to clinical technologists."

As part of the process, Ian Threlkeld, a Fellow of IHEEM, member of the Medical Devices Technology Platform, and Chartered Engineer, who is head of Clinical Engineering at Bradford Teaching Hospitals NHS Foundation Trust, and Dave Easton, FIHEEM, also a Chartered Engineer, and the director and lead consultant at electro-bio medical engineering specialist, Zenger Engineering Services, who chairs the same IHEEM Technology Platform, will join the VRCT registration panel. "Another element of our recent close working with IPEM," Julian Amey explained," is our co-writing, with IPEM and CIBSE, of an 'Engineering and Healthcare' report for the Royal Academy of Engineering. This will highlight the key role that healthcare engineers play in the smooth and efficient running of hospitals and other healthcare facilities in the run-up to the 2015 General Election.

"Largely case study-based, this report should be published shortly, and should considerably raise the profile of healthcare engineers by clearly highlighting the skills, expertise, professionalism, and commitment, of those working in the field, and their considerable contribution to the smooth delivery of 21st-century healthcare."

# German medical gas AEs welcomed

A meeting of Authorising Engineers (MGPS) - all members of IHEEM's register for such personnel - held in London recently saw a variety of topics discussed, a work plan agreed for the forthcoming year, and our two overseas members from Germany, Christian Graack and Jörn Grüneberg, bring an overseas perspective on the role of the Authorising Engineer and the implementation of the technical guidance developed in the UK (HTM 02-01 Parts A&B) and the associated international standards, writes Bill Millar.

A number of actions were agreed, includina:

Raising awareness across the NHS and the private sector of the role of the registered Authorising Engineer, and the benefits such personnel can bring to an organisation.

# **Yorkshire Branch** emergency lighting update

To help ensure that members of the Institute's Yorkshire Branch fully understand current emergency lighting regulations and standards, Alan Daniels, technical director at P4. one of the UK's leading self-testing emergency lighting specialists, recently updated Branch members on recent changes to the 'pivotal reference code of practice in the UK', BS5266 Part 1.

Alan Daniels, who is also a senior member of the emergency lighting sector's main technical body, ICEL, devised his CPD presentation to explain the background behind the changes, and provide clear guidance on the way the latest version of the code of practice should be interpreted and adopted. He explained: "Fire safety legislation changes the nature of the way BS 5266-1 is applied, and it is no longer prescriptive, but rather an essential element in enabling the Responsible Person (or 'duty holder') to demonstrate that their premises are safe."

The P4 speaker also covered testing systems.

- Publishing articles in HEJ on the work of the Technical Platform, with an emphasis on the work carried out by individual registered Authorising Engineers.
