Plans already in hand for this year's flagship event

With last October's Healthcare Estates event having, in the words of the organisers, Step Exhibitions, proved 'an unqualified success', with more visitors filling the isles, conference delegate numbers having grown year-on-year, and the IHEEM Awards Dinner a sell-out, stand bookings for this year's exhibition are already at 55 per cent.

Show director, Steve Webb, explained: "This level of bookings at this stage is a record. Feedback on the 2013 show, and the response to a number of the changes we made, has been extremely encouraging. With increased content and more exhibitors (190, compared with 170 the previous year), we hoped for an increase in visitors and delegates, and that's precisely what we got.

"We aim to build on this in 2014. Healthcare Estates 2014 will take place on 7 and 8 October at Manchester Central, and will incorporate a major exhibition, with sector-focussed theatres providing free content to visitors, run in conjunction with the IHEEM conference and prestigious black tie dinner."

The 2014 marketing campaign will have

'a new look and feel', which will also be reflected in the event website and e-marketing. Steve Webb said: "We will promote a number of reasons to attend, with Healthcare Estates branded as 'a destination', and the event encouraging visitors and delegates to 'focus on quality in the workplace, the patient environment, and the buildings we run'.

"We have recently agreed with IHEEM and Manchester Central that Healthcare Estates will continue to be held in Manchester. Since moving to the city in 2010, we have developed the event, and exhibitors, visitors, and delegates like the venue's close proximity to hotels and restaurants."

Three new membership categories added

At its meeting in late October, IHEEM's Council agreed to the launch of a number of new membership categories, beginning with the Skilled Person Affiliate (*HEJ* – October 2013).

Three new categories have now been introduced – Technician, Crafts Person, and Apprentice. All are corporate grades, permitting the use of IHEEM postnominals, which will be awarded after peer review by the Institute's Membership & Registration Committee.

The Technician category (TIHEEM) has been introduced as part of IHEEM's contribution to the engineering community's drive to increase membership and registration within the country's technician workforce (see also article, pages 18-22). Members awarded this grade will also be eligible for registration as an Engineering Technician, and will be encouraged to aim for this.

The Crafts Person category (CPIHEEM) recognises those technical or trades personnel working in the sector with a minimum level of qualification and appropriate competencies built up through experience. Applicants may previously have felt that Institute membership was not for them.

The Apprentice category (AIHEEM) supplements the existing Graduate grade, and is designed for those just starting out in their career in the sector, potentially on an approved Apprenticeship scheme.

IHEEM's recruitment/membership manager, Chris Parker, said: "The introduction of these new grades completes the recent review, and by introducing these new categories, we are providing a place for a new range of members within the UK's largest specialist institute for the healthcare estates sector.

"Technical and trades personnel have typically felt excluded from membership, and the benefits it brings. By introducing membership and professional development at an earlier stage in their career, we expect new members to want to grow their membership as their career progresses. (see Fig. 1). Professional development is all the more important in our competitive sector, and IHEEM is well placed to provide the tools such members need to progress in their career. These membership categories have been competitively priced to encourage application, and I feel that once our new members have seen the benefits of membership, they will recognise the value it brings."
